## **PRIVACY POLICY**

This information is provided pursuant to art. 13 and art. 14 of the EU Regulation 2016/279, the GDPR (General Data protection Regulation).

### **GENERAL INFORMATION**

This website respects the privacy of its visitors in accordance with the European directives on privacy and use of cookies.

This information has been drawn up in order to facilitate the understanding of the data controller's policies regarding your privacy and the ways in which personal information is processed on the websites. - with the consent of the data subject, send commercial and/or promotional communications on products and services through a specific newsletter service;

### 3. CATEGORIES OF COLLECTED DATA AND PURPOSE OF PROCESSING

# 3.1 NAVIGATION DATA;

The functioning of the website, as well that of any other website on the internet, requires the use of computer systems and software procedures, which collect information about website users within the

scope. Although the company does not collect this information to associate it with specific users, it is possible to identify such users directly through this information or by using other information collected, etc.).

These data are used only to obtain statistical information (therefore they are anonymous) and to check the correct functioning of the site - see Cookie Policy section.

## 3.2 COOKIES;

They are small text files that can be sent and registered on the user's computer by the visited websites, and then transmitted to the same websites when the user visits them again. For further details, please refer to the Cookie Policy on the website.

# 3.3 DATA PROVIDED VOLUNTARILY BY THE DATA SUBJECT;

### 4. MODALITITES OF PERSONAL DATA TREATMENT AND DATA STORAGE PERIOD

Data are processed by electronic and/or manual means for the length of time strictly necessary to achieve the purposes for which the data are collected and, in any case, in accordance with the applicable regulations.

However, we may continue to store such data for a longer period in order to be able to handle any potential dispute related to the provision of the service.

Data processed for marketing purposes will be retained from the time you provided your consent until such consent is revoked. In case of revocation, the data can no longer be processed for marketing purposes but may still be retained in order to manage any dispute and/or litigation.

Data processed to improve the user's experience on the websites will be kept for the periods indicated in the Cookie Policy, depending on the type of Cookie of interest.

### 5. OTHER SUBJECTS WHO MAY PROCESS DATA

Your data may be made available to data processors according to the art. 28 of the GDPR of the data controller.
